



The American Recovery and Reinvestment Act of 2009 provides relief of COBRA premiums to qualifying individuals:

If you were involuntarily terminated on or after September 1, 2008, and are not eligible for other health coverage (such as a spouse's health plan or Medicare), then you may be eligible for a 65% reduction of your COBRA premium for up to nine months. If you didn't elect COBRA, you may have an additional opportunity to elect it now and take advantage of the premium reduction.
